

#### 1. INTRODUCTION

This is the eleventh (11) AWP for FMU10 (Tambunan). For this AWP, all the implementation of prescribe strategies were based on Conservation Area Management Plan (CAMP) Version 2 (**FMU10: CAMP Ver. 2**) which is valid until 2026.

Under the FMU10: CAMP Ver. 2 the Target, Management Zones and Strategies are describe as belows:

#### 1.1 Target

Three (3) Conservation Target has been decided and listed as Table 1.

Table 1: The Conservation Targets and Goals

Upland Mixed Dipterocarp	Restoration of fire degraded and encroached areas with native species

Hornbills*	Determination of the group's distribution and identification of the dominant species

#### \* Note:

All of the hornbills species are listed as Protected Fauna in Schedule 2 under Section 25 (2) of the Wildlife Conservation Enactment 1997; however those birds could still be hunted though Licences issued by the Sabah Wildlife Department

#### 1.2 Management Zones

The management zones has classified to six (6) inline with its functions (Tables 2).

Table 2: The Management Zones

Item	Function
Zone 1:	Conservation Area covering all intact Upland Mixed Dipterocarp Forest (UMDF) and Lower Montane Forest (LMF) vegetations with an approximate area of 42,000 ha in the Nuluhon Trusmadi, all areas in both the Sg. Kiluyu and the Nuluhon Trusmadi (Extension) Forest Reserves
Zone 2:	Aquatic Protection Area that include all water bodies (rivers and streams) and their buffer zones. This zone may cover an approximate area of 4,000 ha
Zone 3:	Forest Restoration Area covering an approximate area of 22,000 ha of largely burnt and encroached areas
Zone 4:	Controlled Hunting Area that extends over some 6,000 ha in the Ulu Monsok and Ulu Rompon area.
Zone 5:	Eco tourism Area covering three (3) climbing routes to the peak of Mount Trus Madi. It may cover an estimated area of 1,000 ha
Zone 6:	Adventure Tourism Area operated by Borneo Jungle Area (BJG) under an Occupational Permit (OP) covering an area of 10.63 ha

This AWP will be the guiding document for the field implementers and the TWG (Technical Working Group) in carrying out their respective duties and responsibilities in conserving and assessing the success or impact of the conservation efforts inline with ten (10) strategies (Table 3). Besides that, the details of implementation schedules, the deployment of the required manpower, budgets and equipments for all implementers both from the Sabah Forestry Department (SFD) and the other relevant Departmental partners in 2019 are highlighted too.



#### 2. FMU 10 (TAMBUNAN)

The original total area for FMU10 as of November 2016 was 75,601 ha. It was made up of the Nuluhon Trusmadi Forest Reserve (Class 1) with a size of 74,736 ha and the Sg. Kiluyu Forest Reserve (Class 1) measuring 1,068 ha. In late 2016, a new area with a total size of of 12,241 ha known as the Nuluhon Trusmadi Forest Reserve Extension (Class 1) was added to the existing FMU10 area. This area was formerly under the FMU5 which was licensed to Anika Desiran Sdn Bhd. With the new addition, the total area for FMU 10 (Tambunan) is currently at 88,045 ha. The Keningau Forestry District administered a size of 47,772 ha of the FMU10 area; while the new area of 12,241 ha is under the Ranau Forestry District and the remaining 28,032 ha are within the Tambunan Forestry District's jurisdiction. Therefore, the FMU10 is currently managed jointly by the Distict Forest Officer (DFO) Keningau, Tambunan and Ranau.

#### 2.1 Objectives

Seven (7) objectives are set for 2019 as listed belows:

- Non destructive usage such as scientific biodiversity expedition, conservation awareness and small scale controlled/licenced flora and fauna collections in the Management Zone 1.
- II) Prohibition of any fishing, riverine or aquatic collections, except for scientific biodiversity expedition or conservation awareness purposes in Management Zone 2.
- III) Maintenance of the 160 ha of the rehabilitated areas and establishment of 20 Ha of new planting in the encroached and fire degraded areas with native species in Management Zone 3.
- Construction and upgrading of necessary infrastructures such as roads, buildings, checkpoint and others ecotourism facilities in Management Zones 1, 3, 4, 5 and 6 that will allow for conservation, ecotourism including mountain climbing and surveillance activities to be conducted or enhanced.
- V) Maintenance and re-brushing of the forest boundaries at Part B of the Nuluhon Trusmadi Forest Reserve to ensure proper surveillance and prosecutions of offenders as prescribed under the Forest Enactment 1968 as well as the Wildlife Conservation Enactment 1997.
- VI) Allowing for limited non-conservation usage, namely Ecotourism, adventure tourism and mountain climbing in Management zones 5 and 6.(refer to Rev. CAMP 2.0).

VII) Compliance of the findings of the annual surveillance audit in 2019 for Forest Certification by FSC in all FMU10 areas.

#### 3. OPERATIONAL STRUCTURE AND BUDGET

The task to coordinate and facilitate the execution of this AWP is the Head Sustainable Forest Management Division, Mr. Musa Salleh, as the Chief Implementer / Chairman for the MPCT and TWG for CAMP FMU 10.

#### 3.1 Operational Responsibilities

The main field implementers of the CAMP in 2019 are the District Forestry Officers (DFO) of Tambunan, Keningau and Ranau. Apart from their respective assigned staff, they are also assisted by the other departmental implementers, namely, the Sabah Wildlife Department (SWD) Keningau office, the Sabah Parks (SP), the relevant research officers from FRC and professional foresters from the Sandakan Forestry Headquarters and the FMU10 Operational Office, Keningau. Figure 2 describes the Organisational Structure in implementing the CAMP Ver. 2 and the Annual Work Plan.

#### 3.1.1 Existing Manpower under SFD

The total available manpower under SFD is ten (10) personnel. However, only eight (8) personnel are considered working fulltime in implementing the CAMP. The other two (2) personnel are part time implementers of the CAMP. **Table 3** above listed the assigned staff and their respective responsibilities to implement the strategies in 2019.

#### 3.1.2 Manpower outside SFD

A total of four (4) personnel are available from the various government agencies (**Table 7**). The agencies involved are the Sabah Wildlife Department (SWD), Sabah Parks (SP) and the District Office Keningau and Tambunan. Most of these staffs however are not working fulltime in implementing the CAMP. Their

involvements are only in the relevant strategies which require their respective expertise.

Figure 2: Organisational Structure for Implementing the Revised CAMP FMU10



## 3.1.5 Maintenance Costs of Vehicles

The total estimated cost for vehicles maintenance and fuels consumption for two (2) units Fortuners and nine (9) Double Cabs are **RM 180,000**. This ammount had been specifically set aside under the D11 Vote.

#### 4. BUDGET AND EXPENDITURE

Table 10 describes the budgets and their sources as well as the amount approved for CAMP FMU 10 in 2019. The total approved sum for CAMP FMU 10 is RM3.65 mil. Under the Rancangan Malaysia Ke 11 (RMK11) & PPM fund, no funding was made available for any of FMU10's activities by the Federal government. The biggest fund for FMU10 was given by the Sabah State government under the RMK11 component. The others two funding were sourced from the Forest Rehabilitation Fund and Community Forestry Fund. All implementers are advised to manage the budget prudently, in view of the limited usage allowed under the various budgets. Payment of allowances to the other departmental partners in implementing their relevant strategies in 2019 will be done using the D11 budget.

#### 5. FOREST CERTIFICATION

The FMU10 was issued with a Well Managed Forest Certification under the Certification Code: SCS-FM/ COC- 005062 and Trademark Licence Code: FSC-C 122511 in 2015 by the Forest Stewardship Council (FSC). The FSC Certificate is valid from May 2015 to 10 May 2020. This year the 4<sup>th</sup> Annual Surveillance Audit of FMU10 is envisaged to be done by the fourth quarter of 2019. A total budget of RM 40,000 is set aside for this purpose.

The TWG for FMU10 decided on the two (2) Major CARs and four (4) Minor CARs under the 2018 audit finding need to be closed by January 2019. The task is given to Mr. Azman Said and continues by Mr Jafin A. Bakar as a new DFO Keningau assisted by Hj. Muhammad Razali Bin Hj.Mohammad, Mr. Suib Basri (DFO Tambunan), Miss. Amy Bosi, Clarice V. Alliun, Marjjah Othman and Ricky Yolok. Appendix 1 describes the major findings and actions done in 2018 while Appendix 2 is describe new list of CAR need to address by the TWG in 2019. The tasks are given to Mr. Azman Said and continue by Mr Jafin A. Bakar as a new DFO Keningau beginning on 01.05.2019 assisted by Hj. Muhammad Razali Bin Hj. Mohammad (SFMO) and Mr. Suib Basri (DFO Tambunan).

#### 6. IMPLEMENTATION OF STRATEGIES

The summary of the ten (10) Strategies and strategic actions for implementation and their respective expenditures in 2019 is further described under **Appendix 3**. **Appendix 4** describes the monitoring activities for the Revised Conservation Targets. All implementers are to take note of those two Appendices for their further guidance.

The details of each strategy are as follows:

#### 6.1 Strategy 1: Boundary Demarcation and Maintenance

There are three (3) Forest Reserves that are managed under this strategy.

#### 6.1.1 Nuluhon Trusmadi Forest Reserve

Maintenance of the boundaries would continue to be done in 2019 (**Table 11**). RH Wihimos Muis and PH Welbert Bitty will oversee the maintenance of these boundaries. The estimated boundary and maintenance cost of RM 50,000 will be procured from the D11 budget.

#### 6.1.2 Sungai Kiluyu Forest Reserve

The whole physical boundaries of the Forest Reserve had been completed since 2016. However, its was made to understand that endorsement and subsequent issuance of the Surveyed Certificate by the Lands and Survey Department for the

physical boundaries of the area was still pending. The point of contention for this delay given by the Authority was for the establishment of a buffer area measuring 5 meter width at some lengths of the surveyed boundary has yet to be done by SFD. The FRM Divison to do relevant follow up with the Land and Survey Department to address these matters.

### 6.1.4 Nuluhon Trusmadi Forest Reserve (Extension)

The total distance to be demarcated was estimated to be approximately 7,000 m. At a rate of RM 5 per meters, a total cost of RM 342,750 is needed to provide. However, the budget allocation for this programme is not available so far.

### 6.2 Strategy 2: Surveillance and Monitoring Activities

This strategy is entrusted to Marjjah Othman in Tambunan, Hj. Muhd. Razali Bin Hj. Mohammad in Keningau, and Elrimieo Emin for the Ranau area. The Field staff would be doing the ground patrolling. The **Borang Pemantauan FMU10** - **01** is to be used to record and logged all ground patrols and aerial surveillances in 2019. Quarterly Reports would be summarised by the respective mentioned Implementers for each areas. These Reports would be put up in the FMU10 Website accordingly.

## 6.2.1 Aerial Surveillance And Ground Patrolling

Aerial Surveillance activities will be carried out four (4) times a year (**Table 13**). Officer of MCEE Keningau will lead the aerial surveillance and he will be assisted by PH Welbert Bitty and RH Wihimos Muis of the Keningau Forestry District. Ground patrol will continue to be done by the relevant field staff. A total cost of RM 240,000 is estimated to be spent on the surveillance activities largely for the payment of allowances in 2019.

#### 6.3 Strategy 3: Forest Restoration

This strategy is monitored by DFO of Keningau. The maintenance of the planted areas at Compartment R16 and R19 in Apin-Apin Keningau (160 ha) is continued. New planting area at Sg. Atug (Southern Part) 20 hectare will be carried out.

The tasks will be implemented as listed bellows;

i. Maintenance of earlier plantings of 2009 and 2010. This involves a total area of 160 ha. A total cost of **RM 295,655.20** is envisaged to be spent for these maintenance works. The contract awarded earlier to Syarikat Jasa Muhibbah in November 2017 by the Headquarters Sandakan for this particular work and it will be continued in 2019 (**Table 15**). Mr. Faizal Awang is given the task to monitor these works.

- ii. To restore 20 ha of the burnt area at Sungai Atug. This area was damaged by fire in 2016. A total amount of RM 128,000.00 is estimated to be spent (Table 16). The contract period is from 17.10.2018 until 16.12.2019 (14 months).
- iii. To Implement the six (6) major components for rehabilitation activities in 2019 (**Table 17**). All the relevant works that need to be contracted out will need to be awarded by April 2019.

## 6.3.2 Monitoring of the Permanent Sample Plots (PSPs)

A total of three (3) of yield plots were established by FRC in October 2010 and another one (1) of new yield plot in July 2013. The assessment will be conducted one time for every two years and will assess by FRC.

## 6.4 Strategy 4: Management of Eco Tourism Activities

The main objective of this strategy is to manage the visitation to Mount Trusmadi through the three (3) climbing routes available, namely, the Wayaan Kaingaran in Tambunan, Wayaan Mastan in Apin – Apin Keningau and Wayaan Mannan in Sinua, Sook. A Committee to deliberate any recommendations to the Chief Conservator of Forests for the Tourism cum Communites Engagement has been established. **Table 18** describes the composition of the Committee.

SFD will continue to train the relevant local communities around FMU10 to be Tourist guides / Mountaine Ranger. A total budget of RM20,000.00 is allotted to be spent.

## 6.5 <u>Strategy 5: Upgrading and Maintenance of Relevant Infrastructures</u> <u>and Website</u>

Implementation of this strategy was shouldered jointly by DFO Jafin A. Bakar, DFO Suib Basri, SFMO Hj.Muhd. Razali B. Hj. Mohammad, ADFO Elrimeo Emin and ADFO Marjjah Othman. The task of managing and updating the FMU10 Conservation Area website will be assisted by Azman Othman of Head, ICT Division.

**Table 20** describes the related activities planned for 2019. All the relevant work to be contracted out in stages beginning in month of March.

## 6.6 Strategy 6: Communities Engagement

This strategy is entrusted to DFO Jafin A. Bakar with the assistance from ADFO Clarice VA, Ricky Yolok, ADFO Marjjah Othman, ADFO Elrimeo and the SFM Division. A Committee as describes in **Table 21** will be tasked to submit relevant recommendations for implementation to the Chief Conservator of Forests.

A final report on the Stakeholders Consultation which was held on 18<sup>th</sup> July 2017 will be completed by DFO Jafin Abu Bakar and submitted to Chief Conservator of Forests (CCF) by the end of June 2019. This report is also including the recommendation in managing Encroachments as Per Cabinet's directive.

Beside that, Communities Meetings and Monitoring of HCV 5 Area and other activities including trainings as describes in **Table 21**. A total cost of **RM 30,000.00** is envisaged to be spent for these activities.

## 6.7 Strategy 7: Wildlifes Surveys in Ulu Rompon and Ulu Pangas

This strategy is headed by RH Wihimos Muis. He will be assisted by PH Welbert. The site for this activity is located along the Jalan Ali Hasan, Apin Apin, Keningau. It stretches from KM 6 (Jambatan Mamat) up to Pangandadan Rangers, at KM 43, which also the starting point for climbing Mt Trusmadi through the Wayaan Mastan.

In this strategy, the morning drive Wildlife Surveys or sightings will be used for five (5) days period every quarterly. The Borang Pemantauan FMU 10-03 is used to record any ground and avian wildlife species sighted.

A total of five (5) wildlife species and evian were sighted via this Methodology in 2018 (**Table 23**).

## 6.9 Strategy 9: Conservation Awareness Programmes

The objective of the Awareness Programme was to provide information and to educate the general public of Tambunan, Keningau, Sook and Ranau on the importance of conserving forested areas and general biodiversity. The task was headed by Clarice V. Alliun for the Keningau and Sook Forestry District, Marjjah Othman for the Tambunan Forestry District and Elrimieo Emin of the Ranau Forestry District.

A total of four (4) Kampungs are selected for the awareness programme in Keningau and Tambunan (**Table 27**). A total cost of RM 50,000 is estimated for this activity.

As same as previous year, the awareness programme is including on talks regarding the management of FMU10, ecotourism activities were given by the respective implementers. Additional talk on the conservation and wildlife protection were given by Keningau Sabah Wildlife Department officer. Each of

these programs culminated with a tree plantings at the vicinity of the balai rayas respectively by the participants.

This strategy is to be implemented by Clarice V. Alliun for Keningau and Sook as well as Marjjah Othman for Tambunan. For the Ranau Forestry District has yet no programme to be conducted in 2019.

The aim of this strategy is to monitor the approved research by the Chief Conservator of Forests. To date the TWG has yet to receive the relevant papers from those researchers as well as the various DFOs. Thus, all the researchers highlighted in **Table 28** will be reminded to submit their work to the TWG as soon as possible. All relevant reports would be summarised in the FMU10 website. Due to the shortage of funding as well as man power, the scientific expeditions in the Nuluhon Trusmadi Forest Reserve (Extension) for the Ranau area has been put off.

#### 7. CONCLUSION

In regard of the Forest certification agenda, the TWG for FMU10 will continue focus on the findings of the 3<sup>rd</sup>Annual Surveillance auditing by FSC last year in 2018. A compliance report will be prepared by Jafin A. Bakar, the DFO of Keningau for discussion by the TWG prior to the next 4<sup>th</sup> Surveillance Audit, envisaged to be held in November 2019.

It is imperative that existing cooperation and commitments of all of staff and implementers be executed to the maximum by the TWG. A few series of operational meeting should be done to resolve any problems or deviations that may arise from such cooperations and plans. A total of **RM 3,423,655.20** is envisaged to be spent from various sources in implementing the AWP for FMU10 in 2019.
